### Hounslow Central

#### Applications

##### 19 Worton Way

Extension of existing single storey porch roof across front of garage to create a canopy with supporting wall to the front of the house.

##### Adjacent To 27 Worton Way\*

Installation of a 18m high Phase eight telecommunications pole with built-in cabinet, three separate cabinets and associated ancillary works.

Certificate of Lawfulness for proposed erection of hip to gable and rear roof extension including two roof windows at the front and one at the rear.

\*Concerns have been raised regarding the application for the erection of an 18 metre telecoms pole on the verge adjacent to 27 Worton Way.

Objections have been lodged with the Council and a decision is awaited. However it is interesting to note that similar applications in residential areas have been refused.
